PASSIONATE ABOUT SUSTAINABILITY? WE ARE TOO!

Enacted in 2019 by City Council approved the SA Climate Ready Climate Action and Adaptation Plan (CAAP), is the City's roadmap to achieve carbon neutrality and to adapt to current and future climate impacts.

HOW WILL SAN ANTONIO REACH ITS 2050 GOAL OF CARBON NEUTRALITY?

Carbon neutrality, in simple terms, means that the amount of carbon dioxide (CO2) an individual, business, or country releases into the atmosphere is balanced by the amount they remove or offset.

The plan has identified six community mitigation strategies as priorities to help adapt and mitigate current and future climate impacts.

Increasing Carbon-Free Energy

Advance the Circular Economy

Biodiversity and Healthy Ecosystems

Reducing Building Energy Consumption

Reducing Transportation Energy Consumption

Educate and Empower

OTHER "SUSTAINABILITY" TERMS:

Urban Heat Islands (UHIs) - San Antonio can get hot. Parts of the city, with numerous buildings and roads but limited natural shade, can become even hotter - sometimes by as much as 20 degrees.

Cool Neighborhoods Program - Led by the Office of Sustainability, the program will test various heat reduction strategies—cool pavements, trees/green infrastructure, shade structures, cool roofs, and weatherization—in four key neighborhoods with tailored installation plans to evaluate their effectiveness.

How can you help Educate and Empower?

Educating residents and businesses about climate action as well as enabling San Antonians to make behavioral and technological changes is an essential element of reducing greenhouse gas emissions. This can be accomplished through policy, training, incentives, financing, and tracking.

Our grant program can provide funding up to \$10,000 for eligible projects!





APPLICATION SUBMISSION + PROCESS

HOW TO SUBMIT YOUR APPLICATION

- 1. Prepare your submission (use the checklist on page 6)
- 2. Go to www.sasustainability.com to fill out the application
- 3. Good Luck! We will contact grant awardees by the end of June or beginning of July 2025

GRANT EVALUATION CRITERIA

- 1. Application Completion
- 2. Project Description
- 3. Budget / Timeline
- 4. Outline of Specific Goals and Audience
- 5. Tell us how your project/program aligns with the SA Climate Ready Plan

OUR REVIEW PROCESS

The Scoring Committee will review and evaluate each proposal and contact you with any questions. The Office of Sustainability and the City reserve the right, solely at its discretion, to:

- Refuse any application or any grant, in whole or in part, for any reason.
- Require additional information from the applicant prior to making a decision.
- If the completed work does not meet the intent of the original project application and award of funds, the applicant will be required to return any funds disbursed.

WHEN YOU ARE SELECTED

You will be notified by the end of June/beginning of July if your project proposal has been accepted and invited to a kick-off event (More details to follow). If your project is selected for funding, you will meet with the Office of Sustainability staff to complete paperwork for

processing. NEXT STEPS TO MAXIMIZE YOUR GRANT'S IMPACT

Upcoming milestones, what to expect, and how the Office of Sustainability will maintain contact with grantees after grants are awarded.

- Submit a final report 30 days following project completion, including:
 - Final metrics
 - Photo or video documentation of the project
 - Documentation of expenses (Example: Scanned copies of all expense receipts.)
- A final report template will be provided
- If the completed work does not meet the intent of the original project application and award of funds, the applicant will be required to return any funds disbursed.
